RESEARCH ON POVERTY AND HOMELESSNESS

Purpose:

The purpose of this document is to present some data regarding poverty and homelessness in and around Perth and the Lanark County in order to educate ourselves and the Perth CFUW members and to provide a concise knowledge base in order to determine our next advocacy steps.

One-bedroom units are in greatest demands average wait time 6 to 8 years. Carleton Place has the longest wait list followed by Perth then Smiths Falls. Housing waitlist as of February 2023: 475 households.

Note from Emily Hollington, Director of Social Services, Lanark County: "While the waitlist is an indicator of demand on a service it is not reflective of need in our community".

Poverty and Homelessness

In Lanark County, 27 individuals were identified as homeless in the 2018 enumeration (homelessness is also something which can be hard to define as there are many people couch surfing or in over-crowded and precarious situations; unsure if the total number quoted includes those)

Reasons For Homelessness (2018)

Unable to pay rent or mortgage: 20.6% Conflict with parent/ guardian: 11.8% Experienced abuse by spouse/ partner: 11.8% Unsafe house conditions: 5.9% Adiction or substance use: 5.9% Incarcerated (jail or prison) 2.9% Conflict with spouse/ partner: 2.9% Other: 35%

Disabilities and Poverty

According to the most recent Canadian Survey on Disability (2017), nearly 917,000 (23%) working-age Canadians with disabilities live in poverty. Persons with severe disabilities (28%) and very severe disabilities (34%) are particularly vulnerable and experience a high rate of poverty. The same survey found that Canadians with disabilities—including women, men, LGBTQ2 people, racialized people and Indigenous people—are more likely to be financially insecure than other Canadians:

- 25 percent of Canadians with disabilities spend more than 30% of their total income on shelter costs;
- Fifty-nine percent of Canadians with disabilities aged 25 to 64 have gainful employment, compared to 80% of Canadians without disabilities; and
- Canadians with disabilities aged 25 to 64 earn less than Canadians without disabilities (12% less for Canadians with milder disabilities and 51% less for Canadians with more severe disabilities).

(Senator Brent Cotter has recently sponsored Bill C-22 in the Senate. Bill C-22 is the creation of a Canada Disability Benefit;

Public Health Food Basket

Each year, with the exception of 2020 and 2021 due to the COVID-19 pandemic, the Leeds, Grenville & Lanark District Health Unit conducts Nutritious Food Basket costing. This means we look at the cost of a variety of nutritious foods across several grocery stores in Leeds, Grenville, and Lanark, and determine the average cost of eating a balanced diet for those living in the tri-county.

Nutritious Food Basket Findings for Leeds, Grenville and Lanark

North Grenville Times found that the average monthly cost of a nutritious food basket in LGL for a family of four consisting of two adults (1 male and 1 female each between 31 and 50 years), a female aged 4-8, and a male aged 14-18 was \$1109 in June of 2022. For a household with a monthly income of \$2760, minus their rent, which is an average of \$1561 in LGL, they have \$1199 for everything else, before accounting for the cost of food. After subtracting the average cost of food, which is \$1109, they are left with \$90 for all other expenses, including hydro, transportation, insurance, basic phone and internet, childcare, clothing and footwear, household supplies, toiletries, and over-the-counter medications, extracurricular activities for children, minimal recreation and entertainment, and school supplies.

Numbers of Seniors accessing Fodd Banks:

Great Food Bank: 137 people over the age of 60

Accessing all programs:

47% of the 50 adult program participants surveyed in The Table annual program survey were over 65, so seniors make up a high percentage of their meal, garden and social justice program participants. The survey doesn't include under 18 or ask about household make up so it underrepresents children.


